## PREQUALIFICATIONS

The contest is open to Kingsport Chamber members and non-members who meet the following criteria:

- Legal residents of the United States.
- At least 18 years of age at the time of entry.
- Legally established **for-profit** small business.
- A corporation, limited liability company, partnership or sole proprietorship. Carrying on business for tax purposes in the City of Kingsport or in Sullivan, Grainger, Hamblen, Hancock, Hawkins, Washington, Unicoi, Carter, Johnson or Greene County.
- Entrant must hold an ownership stake in the business.
- Business must consist of no more than 150 employees.
- Must have earned some significant revenue in the past 12 months. 2016 reported revenue must not exceed \$10M USD.
- The Kingsport Chamber, KOSBE, and its respective employees, and their respective immediate family and household members are not eligible.

## OTHER RULES

- All entry fees must accompany completed entry forms. Your application will not be processed until all applicable fees are received. Make checks payable to KOSBE. Visa or Mastercard accepted.
- All ticket sales and entry fees are non-refundable.
- Post-Interview feedback from expert panel of judges to be provided to all small business applicants to help them improve and focus growth. All judges must sign a conflict of interest/confidentiality agreement to ensure that all entries and details about entrants and their respective businesses will not be disclosed to anyone outside the judging process. All entries will be treated with the strictest confidence at all times.
- Newborn, homebased, agriculture and online businesses also welcome.
